SECTION 4: First aid measures**4.1 Description of first aid measures**

7.1 Precautions for safe handling

- : Keep away from heat, sparks and flame. No sparking tools should be used. Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this mixture. Avoid inhalation of dust from sanding.

8.2 Exposure controls
